The Medical Information Coder/Biller: Health Information Management program is a College Credit Certificate consisting of 34/35 college credit hours and is approved as a Comprehensive Coding Program by the American Health Information Management Association (AHIMA). Upon program completion, students have the technical skills necessary to enter the healthcare delivery market as an entry-level medical coder and medical biller.

For students who want to advance their career opportunities, SCC offers an Associate in Science in Health Information Management (A.S. Degree-HIM; starting Fall 2008). This degree is needed if a student wants to continue on to a bachelor's degree program.

Medical coding and billing skills are taught manually and enhanced with coding and billing software applications. The knowledge gained from the Medical Information Coder/Biller: Health Information Management Certificate prepares students to become a nationally certified coder. Day, evening and online courses are available. The major courses are available evening/online. Students must have access to a computer with Internet capabilities while enrolled in the program (access to computers is available at SCC campuses, see regulations on computer access at <http://www.scc-fl.edu/policies-procedures/policies/1.140.htm>).

The College Credit Certificate and A.S. in Health Information Management degree are limited-access programs. Candidates must meet minimum CPT/SAT/ACT scores or provide transcripts with proof of ENC1101 English I with a grade of 'C' or better prior to registering for the following courses: HSC1531, HIM1450/HIM1453, and HIM1000. Additional prerequisite courses are required for the A.S. in Health Information Management degree program (see course sequence below). All students are required to have a criminal background check prior to internship placement.

Medical Information Coders/Billers are usually detail oriented, analytical, investigative, like to read and thrive in the knowledge of medicine. If you fit this profile, SCC's Medical Information Coder/Biller program might be right for you!

Career Opportunities

Medical information coders/billers impact several aspects of healthcare, most importantly billing, reimbursement and statistics. Job opportunities abound for medical coding and billing specialists – within hospitals, physician offices, managed care organizations, and medical billing companies. Managing, analyzing, and coding medical information is expected to grow through the year 2015 (Reference: Fastest Growing Occupations, Workforce Region 12; www.workforcecentralflorida.com; accessed 3/08).

Medical Information Coder/Biller Certificate

Upon completion of the program, the student has the technical skills that are necessary to enter the healthcare delivery market as an entry-level medical coder and biller. The student also possesses the knowledge to become a nationally certified coder. Day, evening and online courses are available. SCC Medical Record Coder/Biller graduates are employed throughout Central Florida at companies such as The Coding Edge, Inc., Physician Associates of Florida, Florida Hospital, Orlando Regional Healthcare, and United Healthcare to name a few.

Licensure/Certification

The American Health Information Management Association (AHIMA) and the American Academy of Professional Coders (AAPC) both sponsor a certification examination for medical record coders. Upon successful completion of the AHIMA certification exam, the medical record coder is given the title of certified coding specialist (CCS), which is a professional skilled in classifying medical data generally in a hospital setting. There is also the CCS-P, which is a coding practitioner with expertise in physician-based settings (physician offices, group practices, or specialty centers). Upon successful completion of the AAPC examination, the medical record coder is given the title of certified professional coder (CPC) or certified professional coder hospital (CPC-H).

Salary

In 2007, the mean hourly wage for Medical Records and Health Information Technicians in Florida was \$15.07/hour. (Reference: Florida Agency for Workforce Innovation, Labor Market Statistics, 2007. <http://www.labormarketinfo.com/library/oes.htm>)
